Emphasis: The Tax Reform Act of 1976 made the most drastic changes in Federal estate and gift taxation in almost 30 years. Mr. Weinstock's book is one of the very few comprehensive texts on estate planning which is up to date under the new law. This publication is designed in such a way that it can be read from start to finish and give the reader an understanding of the entire subject. It can also be used as a reference book on a specific point which the reader may wish to look up. Sufficient theory is presented so that the reader can evaluate, for himself, alternate solutions. The author's aim, however, is to have the book serve as a practical planning guide.

The Author: Harold Weinstock, a graduate of Harvard Law School is a member of the Los Angeles firm of Walzer, Weinstock, Manion & King, a Law Corporation. He began his legal career as a Special Attorney for the office of Chief Counsel of the Internal Revenue Service. Eight years later he went into private practice, specializing in estate planning and taxation. For the past 18 years he has practiced law, taught classes, conducted seminars and been a frequent lecturer at the U.S.C. Tax Institute and for the California Continuing Education of the Bar on tax and estate planning. During this time he has also written many articles on these subjects.
